Terms and Conditions of Engagement of Project Manager in PMU for implementation of National Action for Mechanised Sanitation Ecosystem (NAMASTE) scheme

1 Eligibility criteria for selection of Project Manager

a. Essential:

- 1) **Graduate or Post Graduate degree from a recognized university** in Urban Planning, Social Work, Public Policy, Business Administration, Sociology, Anthropology, Commerce, Science or other related fields, with at least 55% marks.
- 2) Two years' relevant work experience in case of Graduate candidates
- 3) Excellent communication (both oral and written) in English and the official language of the State/UT of deployment.
- 4) Computer proficiency in MS Office and proficiency of working on various mobile applications.
- 5) Age between 21 years to 35 years. (as on 01.07.2023)

b. Desirable:

1) Relevant work experience of two (02) years for Post Graduate Candidates.

2 Selection of Project Managers

The eligible candidates shall be selected after shortlisting and personal interview.

3 Terms and Conditions to deploy Project Manager

- a) The Project Managers would work on full-time basis for the project and would not be allowed to engage themselves for any other project/ work during the duration of the National Action for Mechanised Sanitation Ecosystem (NAMASTE) project.
- b) Project Managers would be selected for a period of two years. However, their engagement may be extended based on requirement and performance of Project Manager.
- c) The engagement would be purely project based and temporary. They will have no claim whatsoever for continuing their services in any capacity.
- d) The Project Manager would be paid fixed monthly remuneration of Rs.55,000/- per month inclusive of local transport and applicable taxes and statutory dues.
- e) No TA/DAwill be paid for their movement in NCR.
- f) Project Manager would be required to arrange a good working condition laptop and Smart mobile phone during the period of engagement for his/her use. For this, they will not be paid any extra amount.
- g) Project Manager will get benefit of one leave per month.
- h) Project Manager will not be allowed to show any political affiliation during the project period. They will work without any favour with any section of the society.

 Except with the prior written consent of NSKFDC, Project Manager shall not, at any time, communicate to any person or entity any confidential information acquired in the course of the Services.

4. Scope of Work for Project Managers under NAMASTE

- a) They would be initially deployed in Delhi but will have the liability to serve any where in India.
- b) Project Manager would
 - 1) Assist the concerned officer of NSKFDC/Ministry or any other organisation as per the directions of NSKFDC.
- 2) Obtain the progress of implementation of NAMASTE in the ULBs/States and make reports
- 3) Regular follow up with the concerned ULBs/Sates for taking action for implementation of the Scheme.
- 4) Regular updation of MIS on the NAMASTE portal.
- 5) Interaction on mobile with the various implementation agencies etc.
- 6) Any other work assigned
