#### 3. SCOPE OF WORK

### 5. EARNEST MONEY DEPOSIT (EMD)

Subject to compliance of response submission process, the intending bidders should pay along with bids an Earnest Money Deposit of Rs. 10,000/- (Rupees Ten Thousand Only). #### 6. ELIGIBILITY CRITERIA

#### I. Eligibility criteria/Qualifying requirements of Architect/ Interior Designers firms

- (a) Since Architectural concept and design is the prime consideration, reputed Architect / Architectural firms shall be the main lead for the project. Hence applications from registered entities including individual / firms/LLP/Companies with major exposure to Architecture and an experience of at least five years will be considered.
- (b) The intending agencies that have experience of executing similar works of commensurate financial value (as defined in Annexure III) including with Government of India/State Government/Central Public Sector Enterprises/Public Sector Banks/ other autonomous bodies/institutions under Central or State Govt., will be given prioritiy.
- (c) The Architect / Architectural firms /LLP/Companies with minimum 5 years of extensive experience of rendering architectural concept / design and /or similar services.
- (d) Architectural and Design Consultancy entity shall possess expertise and experience in interior design of institutions/public buildings incorporating relevant and latest emerging features in the field.
- (e) Architectural and Engineering Design Consultancy entity shall have adequate in house expertise and experience in planning, designing of architectural concept and designs, structural, civil, public health, Electrical, Fire fighting systems, Building Automation, LAN, Interior works etc., as required for the work
- (f) Architectural and Engineering Design Consultancy entity that follow the eligibility criteria laid down by the Council of Architecture (India) are eligible to participate. The onus of the Architect and Engineering Design Consultancy firm's eligibility as per the Council of Architecture (India) guidelines shall rest with the firm itself.
- (g) The entity should have current and valid registration.
- (h) The tabulation on various parameters to be fulfilled as per the eligibility criteria and the allotted marks for each are available at Annexure-III.

#### II. General Instructions

1) The selected bidder shall indicate the authorized signatories who can discuss and correspond with NBCFDC, with regard to the obligations under the contract.

- 2) The application shall be signed by the persons on behalf of the organization having necessary authorization/ power of attorney to do so. Each page of application shall be signed (copy of power of Attorney/ Memorandum of association shall be furnished along with the application and original should be produced subsequently for verification and return.)
- 3) Intending applicants are required to submit their full Bio-Data giving details about their organization, experience, technical personal in their organization. Proven competence to handle major works, in house computer aided facilities etc. in the enclosed Performa.
- 4) The application must be accompanied with registration certificate under council of Architect, PAN card with IT return for last 3 years, service tax/ GSTN registration.
- 5) If the space in the proforma is insufficient for furnishing full details, such information may be supplemented on separate sheets shall be used for each part of the application. Separate sheets must be duly signed and sealed.
- 6) The applicant (Architect Consultants, Interior Designers' entity) must have at least two On roll qualified graduate Architects experience of preparation of concept plan, structural design & drawing, services, landscape ancillary works and cost estimation based on current Schedule of Rates of Delhi and non- Schedule items if require based on market rate analysis. (Proof of Employee Should have to be Submitted)
- 7) The applicant may engage the services of well qualified specialists or consultants pertaining to services., relevant to the work at his own risk and cost and no extra payment will be made by NBCFDC in this regard.
- 8) While filling up the application with regard to the list of important projects completed or on hand, the applicants shall include separate sheet in the prescribed format. Services to be rendered by the consulting firm.
- 9) a) To take instruction from NBCFDC and prepare sketch designs/ presentation drawings making revisions till sketch designs are finally approved by the Mission and making preliminary estimates of cost.
  - b) To prepare architectural working drawings, structural drawings including, services drawingselectrical, plumbing sanitary, fire fighting and all other drawings for various trades required for completion of the particular project.

- 11) The applicant, if shortlisted for the presentation stage, will require to present the rough estimates of the proposed work.
- 12) The total consultancy fee and schedule of payment shall be duly filled up as per annexure IV. The consultancy fee shall be inclusive of GST and any other taxes as applicable. Deduction of income tax etc. will be made at source at the time of making payment.

#### 7. General terms and conditions

- Bidder shall, as part of their bid, submit a written Authorization Letter as per specified
   Form in tender from Proprietor / Partner/Director of Bidding firm/ consulting company if
   the signatory is other than Proprietor /Partner/Director.
- Bidding documents shall at all times remain the exclusive property of the NBCFDC.
- NBCFDC reserves the right to accept or reject any Bid and to annul the Bidding process and reject all Bids at any time prior to award of contract without assigning any reason whatsoever, without thereby incurring any liability to the affected Bidder or Bidders or without any obligation to inform the affected Bidder or Bidders of the grounds or the reasons for the said action.
- Canvassing in any form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- In case any bidder is found to be involved in cartel formation, his bid will not be considered for evaluation / placement of order. Such Bidder will be debarred from bidding in future.
- The bidder/contractor shall not sublet, transfer or assign the contract or any part thereof to any other person / firm / consulting company / organization/firm.

### 8. Scrutiny & Evaluation of Bids

- 8.1 The documents submitted in terms of check list at Annexure III will be scrutinized and marks allotted to each bidder in such a manner that the bidders having credential twice the minimum criteria will be awarded full marks for the said parameters and other awarded marks on a prorata basis. The maximum marks for submission of documents will be 25.
- 8.2 All bidders who have fulfilled the minimum eligibility criteria by way of submission of all the documents will be invited to presentation on the following aspects, which will carry an added 25 marks; (bring out the aspects)
  - a) It is to be explicitly noted here that bidders not submitting the requisite documents to establish fulfillment of each and every eligibility criteria will not be invited for presentation regardless of the marks they obtain against eligibility criteria.

- 8.3 Price Bids of all bidders who have fulfilled all the minimum eligibility criteria & secured more than 35 marks will be opened and work will be awarded on the Least Cost System 'LCS" wherein the qualified bidder quoting the minimum price will be selected after due scrutiny of the reasonability & workability of the rates.
- 8.4 Note: Conditional bids will not be considered as technically responsive and may be summarily rejected.

#### 9. Award of Work

- 9.1 NBCFDC will issue a Letter of Award for sanction of work in duplicate reiterating all the concerned terms & condition and scope of work which should be accepted within one week by the successful bidder by signing in all pages of the sanction letter as a token of unconditional acceptance.
- 9.2 Performance Security Deposit An interest free Performa Security Deposit in the form of DD payable @10% of the quoted value of work (exclusive of taxes) will also require to be submitted to NBCFDC, which will be refunded to the bidder on or after satisfactory completion of the work/activities.
- 9.3 The successful bidder may exercise the option of adjusting the unreturned EMD as part of the PSD by giving a written confirmation to this effect.

#### 10. Delivery Period & Liquidated Damages

As the time is the essence of the contract Agreement, the ability and competence of the applicants to render required services within the specified time frame will be the major factor while deciding the selection of the Architects.
