1. BACKGROUND

National Backward Classes Finance and Development Corporation (NBCFDC), is a Government of India Undertaking under the aegis of Ministry of Social Justice & Empowerment. The Corporation was incorporated on 13th January, 1992 as a Company not for profit under Section 25 of the Companies Act, 1956 (now under Section 8 of the Companies Act, 2013), with an objective to promote economic and developmental activities for the benefit of members of Backward Classes living below double the poverty line through State Channelising Agencies (SCAs).

As on 31.3.2017, NBCFDC has disbursed loan of Rs.3575.50 cr at concessional rate of interest to benefit over 20 lakh Backward Classes people throughout the country since its inception. It boasts of robust linkage with Channel partners including State Corporations, Public Sector Banks and Regional Rural Banks which are ensuring effective disbursement & recovery of loans. The Corporation has simultaneously tied up with reputed Skill Development & Entrepreneurship, to provide much needed employment generating training programs to the under privileged. The details of NBCFDC's schemes and other activities can be seen at our website www.nbcfdc.gov.in.

- 2. Applications/bids are invited from Organizations for empanelment with NBCFDC to spread awareness & provide hand holding to poor OBC persons for availing benefits of NBCFDC schemes. Interested institutions, who fulfill the following criteria and experience may apply for empanelment with NBCFDC.
- **3. Eligibility:** Institutions/non-profit Registered Societies/Trusts & such bodies which are duly registered under any statute in India are eligible for empanelment, who fulfill the following criteria:

4. **Procedure for Empanelment :**

NBCFDC officials would open and scrutinize the EOIs and those Organizations who qualify the eligibility criteria as mentioned in para 3 above shall be invited for presentation before the Committee on their

- experience, strength and proposed specific interventions for upliftment of the target group of the Corporation.
- Based on the interactions held and clarifications provided as per record, those bidders found suitable for partnering NBCFDC towards increasing the coverage and effectiveness of the Corporation's scheme amongst its target group, may be empanelled.
- **iii)** The number of Organizations to be empanelled shall be determined by the NBCFDC based on the requirement.
- **iv)** The empanelment shall be made initially for a period of 2 years by signing a MOU which will clearly bring out the mutual responsibilities & commitments.

5. Terms and Conditions of empanelment :

The purpose of the EOI is the empanelment of suitable and willing Organizations working at the ground level for socio economic upliftment of the marginalized sections of the population specifically those belonging to the other Backward Classes, with a view to utilizing their reach for popularizing the development & financing initiatives of NBCFDC & mobilizing persons of the target group avail the benefits of Corporation schemes. NBCFDC schemes are available at NBCFDC website.

NBCFDC will sign MOUs with such Organizations wherein the broad responsibilities of the two entities will be as under :-

5.1. Responsibilities of Organization

- a) To identify clusters of persons belonging to 'Other Backward Classes' specifically artisan weavers & craftsmen, who stand to benefit from NBCFDC schemes of loaning, skilling, market linkage provision & cluster development.
- b) To spread general awareness of NBCFDC schemes to the target group. Therefore, Organization conversant with local conditions, fluent in local

language, willing to reach out to people in urban as well as in rural areas will be preferred.

- c) To handhold persons of target groupfor availing the benefits various schemes by interfacing with State Channelizing Agencies, Banks and skill partners and other stake holders of NBCFDC.
- d) To specifically assist prospective beneficiaries in preparation of project reports and other documentation activities leading to undergoing training followed by placement and/or availing of loan under NBCFDC schemes by persons of the target group.
- e) To help create self help group/clusters to take effective advantage of NBCFDC schemes.
- f) To give feedback to NBCFDC from time to time for improving the reach and effectiveness of the schemes so also other low cost welfare interventions which can be covered under the Corporation's CSR ventures.

The persons engaged in mobilizing work of NBCFDC will not be eligible for any concession or appointment with NBCFDC.

5.2. Responsibilities of NBCFDC

- a) To provide all necessary information and literature on schemes of Corporation propagation to target group.
- b) To organize awareness camps with due coordination of banks, Sector Skill Councils & other partners.

- c) To facilitate skill development training in identified sectors for OBC persons mobilized by the Organizations. The training will be in terms of the Common Norms and executed by Sector Skill Councils and other government institutions.
- d) To facilitate by way of interactions with State agencies and Channel Partners for provision of loan for self-employment ventures for the target group persons mobilized by the agency.
- e) To enable participation of the target group in cluster development & other initiatives of Government of India for their socio economic development.
- f) To pay mobilization charges @ Rs.300/- per candidate (max.) on compliance of activities mentioned in 5.1 and specifically outcome mentioned at 5.1(d).

Submission & Evaluation of EOI application.

- i) Expression of Interest (all pages) alongwith supporting documents must be duly signed by the Authorized Signatory. The entire set of documents are required to be sent to GM (Project), National Backward Classes Finance & Development Corporation, 5th Floor, NCUI Building, August Kranti Marg, New Delhi-110016 on or before 15.06.2017 upto 2.00 PM.
- ii) In the event of any doubt or difference of opinion regarding the terms and conditions of empanelment, the decision of the NBCFDC shall be final and binding. NBCFDC reserves the right to amend, modify and change the terms and conditions of empanelment as deemed necessary.
- iii) Please note that the Empanelment process can be cancelled by National Backward Classes Finance & Development Corporation (NBCFDC) on its discretion.
