National Backward Classes Finance and Development Corporation (NBCFDC), a Government of India Undertaking under the aegis of Ministry of Social Justice & Empowerment and has an authorized share capital of Rs.1500 Crore against which the Ministry has so far released Rs.1024.00 Crore. NBCFDC was incorporated on 13 January, 1992 under Section 8 of Companies Act 2013 (earlier Section 25 of the Companies Act, 1956) as a Company not for profit with an objective to promote economic and developmental activities for the benefit of Backward Classes and to assist the poorer section of these classes in skill development and self employment ventures. Members of Backward Classes having annual family income less than double the poverty line (i.e. Rs.98,000/- in rural areas and Rs.1,20,000/- in urban areas) are eligible to obtain loan from NBCFDC.

The Corporation facilitates the Skill Development Training for the target groups for ensuring self and wage employment and wage enhancement as mentioned in the Common Norms issued by Govt. of India and any other guidelines that may be issued from time to time.

- The expression of interest is solicited in the form of concrete proposal indicating name of the training programme, Location & No. of Trainees, cost per hours (as per PMKVY) level wise, duration, placement services, handholding etc., for collaboration with NBCFDC. Training Institutes are required to ensure the compliance of NSQF/NVEQF/NVQF/MES Level & Common Norms of Ministry of Skill Development and Entrepreneurship.
- NBCFDC particularly looks forward to proposals of RPL for reskilling & skill upgradation of artisan clusters already engaged in an occupations and bridge courses for beneficiaries in the experiential training.
- 3. The training institutions should be under the aegis of Central or State Government etc. with adequate and approved training facilities and infrastructure. Additionally all Sector Skill Councils (SSCs) constituted by NSDC under Ministry of SDE may also submit proposals.
- 4. 70% wage & self employment of trainees and or wage enhancement, shall be ensured by training institutes.

- 5. Details of wage employment and self employment be provided in the prescribed format and would be uploaded on the website of Training Organization and tracking of trainees upto one year.
- 6. The proposal already submitted by eligible training Institute/SSCs to NBCFDC during current financial year need not to submit again.
- 7. The submission of proposals will not entitle the applicant for award of training programmes and decision of NBCFDC will be final and binding in this regard.

The proposal should be sent in sealed envelope latest by 25.05.2016.
