The sealed quotes, shall consist of 2 parts – <u>"Technical bids" & "Financial bids"</u>. Financial bids, of only those agencies, would be unsealed who qualify in the technical bids.

Different Agencies may be awarded work in different States.

It may please be noted that the decision of the Managing Director, NBCFDC shall be FINAL & BINDING on all the parties.

For settlement of any disputes only Courts in Delhi shall have jurisdiction.

### Scope of work

Physical inspection of the individual beneficiaries to know;

- (i) the assets created by the beneficiary out of NBCFDC loan, If not created the reasons thereof.
- (ii) Utilization of loan for the purpose it was obtained. if not used for the purpose the reasons thereof.
- (iii) beneficiaries found during inspection who have crossed poverty line after availing loan from NBCFDC and the increase in their income level.
- (iv) Impact of NBCFDC schemes on Socio-Economic condition of the beneficiaries;
- (v) Difficulties, if any faced by beneficiaries in obtaining the loan/assistance and time taken in obtaining the loan, Recovery from beneficiaries and SCAs and suggestion for improvement.
- (vi) Suggestions for improving the implementation of NBCFDC scheme at grass-root level as well as District and Head Quarter level of SCAs.
- (vii) Marketability of products made by beneficiaries and suggestions for improvement.

- a) The Evaluating agencies are required to physically inspect and verify the assigned number of the beneficiaries assisted under NBCFDC schemes during the last 5 years. (The list of beneficiaries assisted during 2010-11 to 2014-15 will be obtained by evaluating agency from respective SCA.)
- b) The objective of the study is to ascertain

  - % age of beneficiaries found during inspection to have crossed poverty line.
